



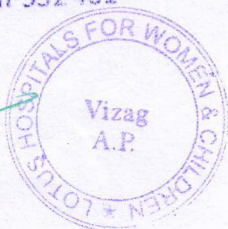

Clause 1

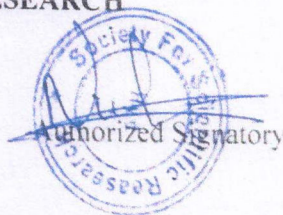




